- Registrar / Registration
  - o Midseason Reduction in place on Friday, April 26.

    - Jason to e-mail league.
  - Work with GroupNet to get Fall registration database up and running
    - Complete by June 3 (estimated).
  - Test registration portal/database
    - Complete by June 20
  - Registration open July 1 or earlier.
  - New Team Application Form/Deposit to be sent to new teams.
    - Several groups waiting to join the league as new teams
  - Players can still Opt-In to show e-mail in database
    - Positive feedback on this
  - o Poll Question about tournament can remain
    - Fairfax County indicated there would be limited to no field space for tournaments, so this is unlikely.
  - o Passes for Fall 2013
    - "New" 2013-2014 passes will not be required
    - Too much chaos surrounding pass distribution this spring.
    - Updated 2013-2014 passes can be distributed after the Fall 2013 season.
  - MDCVSA Update

- Jason informs board that MDCVSA will be migrating to a new registration portal in 2013. Not clear how that will impact NVASA's registration. Jason to follow up.
- Treasury
  - Spring 2013 Budget Discussion
    - Fairfax County Fees paid
    - 1<sup>st</sup> half referee fees paid
    - Demosphere fees paid
  - o Tax Status
    - Amily/Jason working with accounting firm/IRS to resolve old issues with filing.
    - Goal is to submit a 1023 application in the near future to apply for nonprofit corporation status.
- Pass Distribution
  - o Ryan indicates teams need to pick up passes still
    - Ryan will send follow up e-mails.
- Disciplinary
  - Marvin to provide update
    - No outstanding issues. One sanction notification pending.
- Misc

  - Captain's Guide
    - Feedback has been very positive since it was e-mailed out
    - Some updates needed based on suggestions from captains
  - o Subbing discussion / Minimum roster size
    - Challenges as to how to enforce min. roster size, if at all.
    - Subs are still used heavily and excessively. One team recently used 10 subs.

- Finances
  - o Restructuring of fees for Fall 2013 / roster size discussion
    - Any changes need to be researched and detailed with justification
    - Raise fees for primary or secondary team?
    - Discussion was inclusive as to how to move forward.
    - Jason requests all board members send him proposals as to how to restructure fees or increase revenue through minimum roster sizes.
    - Root cause of revenue decrease is significantly smaller rosters since Fall 2012.
