 - Tool used to attract NEW players to league
 - Only for players NOT registered for an NVASA team for that current season (player can previously have played for an NVASA team in a prior season).
 - \$15/ two games (two sub packs MAX/person)
 - Overall cost of the sub pack(s) will be deducted from the team registration fee if said player decides to fully register for a team in NVASA that same season.

 - For players REGISTERED for an NVASA team
 - After three subs with a particular team \$10/game (No Limit)
