**Call to Order**

**Reading of the Minutes from Last Meeting** – waived

**Treasurer's Report** (Phil Zeigler)

- Balance Sheet – we owe \$8500 to FC; made \$1500; excess \$6800  
fees won't add up but we will budget  
Ref fees increased
- New – line fees
- New framework for sponsorship – need help of captains to let league/teams know of corporations willing to sponsor/help Phil to solicit (Phil, “No skills”)
- *Questions:*
  1. *Q -- What is “assignor”?*                    *A – the person who contacts refs (has been Jeff Klopp)*
  2. *Q -- Is budget less for refs than last year?* *A – we're only looking at ½ year right now (teams up 30%)*
  3. *Q -- Current sponsors?* *A – none (Glory Days - close; Columbia Tourney & Soccer Academy -possibly)*
  4. *Q -- Tax Status?*                    *A -- May 26<sup>th</sup>*
  5. *Q – Field Lining Fees?* *A – Has been Commish's job [thanks given]; Tony Dileo will be lining*

  - Requesting Field Monitor to coordinate checking of fields (Lou)
  - Show county we're organized/other organizations held accountable for field use
