I. State Association Registration

- Demosphere and state site will not mesh
 - o Demosphere has made all required changes except one (record of players' teams)
- Everything this state assoc. year (fiscal) will be the same
 - o will change in the Fall 2010 state fees to be paid individually, online
 - o League Team fees will be calculated less the state fee (players will pay state directly)
- We will be notified when a player has been approved
- Winter players will be calculated individually
- Instead of splitting spring and fall, will pay total amount for year in fall
- We will be a part of pilot program (online registration)
 - Options: 1. players just pay state assoc. fee; 2. players pay league as individual; 3. teams pay league
 - o Pros: accurate info for state; less work for captains and league
 - o Cons: how to manage # of teams each player has
 - Could we give registered players a "pass"?
 - WASL allows special, limited "sub" fee in addition to regular roster
 - Could increase roster to 30

II. Finance

- Check \$1900 team fee
- PayPal/Credit Card \$1960 team fee (3% charge)
- 50% increase in out of county fees from \$20 to \$30
- Added ref mentoring program
- 2 scales for refs: double slot \$120; single slot \$130 (\$115,000 expected; \$126,000 actual)
- Dropped league tail gate, but bought more tickets (6 instead of 4)
- \$300 back from DC United (has been declining)
 - o They will provide flat \$500 for certain number of season ticket slots
 - o Compromise to avoid extra single ticket sales on game days

III. Captains Meeting – Feb. 28th (Sunday); tentatively Café Asia (time TBA)

IV. Start of Season – March 14; grass fields open April 1

- Sharon will take volunteers to start early
- Checks to be deposited March 29 (Monday)

V. Discipline

- Need "So You Just Got a Red Card" document on website
- Lou's constitutional change proposal:
 - o Teams need to supply an "account" of what happens within 48 hrs.
 - o If goes to panel, decision announced in no more than 7 days from incident
 - o Small board (3-person: Commish, CJ-AC, ?) review to decide if issue goes to panel
 - o CJ-AC sends dispute to odd number in pool of panel members
- Discussion of necessity for "carded violation categories" decided "NO" not feasible

- Discussion to add just addition to current language:
 - "Red cards go to disciplinary panel except for 'Double Yellow Card' and 'Denial of Goal Scoring Opportunity"
